

INVITATION

I am pleased to invite you to participate in the annual conference of agile civil society in Bosnia and Herzegovina, Civilka.

Civilka is gathering relevant stakeholders from different sectors who openly and courageously question the most sensitive and important issues related to the development and values of civil society in Bosnia and Herzegovina, in order to strengthen and promote this sector, which is often considered a pillar of the development of democracy in every country. The civil sector should return to the path of development and strengthening with planned, coordinated, and purposeful support from local authorities and the international community. Our goal is to start open discussions about issues in the civil sector that lead to stagnation and reduction of space for civil society oriented towards results and impact on the improvement of quality of life for the citizens in BiH.

The conference will be held on December 12, 2022, starting at 10 a.m., in the My Face, Vilsonovo šetalište 8, and the topic of the first Civilka is "Results EXIsT", where we plan to talk about the effectiveness of projects in BiH.

Why this particular topic? In the post-war development of BiH, thousands of projects were implemented, with billions of KM of financial support from the international community as well as local authorities at various levels. However, looking at the overall picture, it is clear that positive changes in our country are happening very slowly or not at all and that the development of BiH and democracy is at an unacceptably low level. Why do we have more outputs than results from projects and how to achieve better use of funds that taxpayers of the EU, BiH and other countries allocate for projects implemented in Bosnia and Herzegovina? Why is civil society weakening? How much are donor policies, authorities and/or civil society organizations responsible for this situation and how can we contribute more to the development of BiH society?

Together, we will try to find answers to these questions and make concrete proposals to increase the efficiency and effectiveness of projects in BiH. For this topic, CPCD has prepared a policy paper that we will supplement with inputs from Civilka and use in the post-conference period as an advocacy tool towards donors, decision-makers abroad and locally.

The agenda of Civilka No. 1 is attached to this invitation.

We hope that you will make an active contribution by participating in Civilka as well as through advocacy activities that we will jointly discuss on 12th December 2022.

Participation at Civilka is free. This conference is not supported by donor funds, so, unfortunately, we are not able to cover travel expenses and accommodation for participants.

Looking forward to seeing you at Civilka No. 1 - the most exciting and open discussion about civil society!
